Gold is in a long term uptrend which is represented by the green channel on the 1st page. The more recent down leg is represented by the red channel.

Gold is currently testing \$1764.85 support and dipped its toe below for a few ticks before rebounding above on Friday.

If the channels provide guidance, I'm thinking the chart makes its way to where they intersect at about the \$1700ish level. If the \$1764.85 level holds and it breaks the upper red channel line we could be on our way to new highs.

LOMIKO SEES BIDEN'S \$400 BILLION COMMITMENT TO CLEAN ENERGY AS AN OPPORTUNITY FOR QUEBEC MINE DEVELOPERS

Lomiko has been monitoring emerging legislation aimed at reducing North American dependence on Chinese supply of graphite and other electric vehicle battery materials.

ur featured company is focused on the exploration and development of flake graphite in Quebec for the new green economy.

Lomiko is a Canadian-listed junior graphite exploration and development company. It's flagship asset is the La Loutre graphite deposit, located in Quebec, Canada about 120 km north-west of Montreal and 53 km southeast of the currently operating Imerys Graphite and Carbon Timcal Lac des Iles graphite mine.

The La Loutre deposit currently has an NI 43-101 compliant resource estimate completed in 2016, with 4.1 M tonnes of 6.5% flake graphite in the indicated category and 6.2 M tonnes of 6.1% flake graphite in the inferred category based on a cut-off grade of 3% in a open pit.

Lomiko plans on updating their resource estimate soon, integrating drilling data from 2019 in the property's Refractory Zone which features some notable, relatively long and high grade intercepts that would expected to add tonnes and potentially improve the grade of the overall deposit.

Lomiko just completed the remainder of purchase and now owns 100% of the property. The resource estimate update is currently expected in Q1 of 2021.

olonial Coal [CAD - TSX-V] touched .66 on Friday and then bounced back to close up 3 cents to .72 on the day on 427,825 in volume. There is support in the .66-.70 range were bidders are getting some fills. Please see my comments from our last newsletter.

The Shares

I think it is important to emphasize that Colonial Coal's float is a lot smaller than the 183M outstanding, much smaller!

Only insiders and people with more than 10% have to declare. Last transaction was Rosseau Asset Management buying 250,000 shares at .75 on Sept. 29th, 2020.



Benz Mining [BZ - TSX-V] released their wildcat drill results on February 9th and the stock sold off. Benz dropped to a low of .81, filled the December gap up (the spike on the Australian listing) and has since started to climb back up. Closed at .94 on Friday. Please read my comments from two weeks ago.

The Latest News

The holes reported were from the fall drill program which was a very exploratory wildcat program. They were testing FLEM/ DHEM Modelled Conductors to see if they could predict where the mineralization would be. Well it worked!

The assays confirmed the discovery of 2 new trends at Eastmain. One intercept was 85.0g/t over 0.4m. Other intercepts included 8.5g/t over 3.8m and 13.7g/t over 3.0m.

"The presence of coarse gold in hole EM20-132 indicates potential nugget effect and all intervals displaying mineralization will be re-assayed either by metal screen (1000gr) and AA assay or photon assays to get a more accurate measurement of the zone's gold grades."

Read the <u>full news</u> to understand how they are exploring for mineralization. The core even had some visable gold and I would suspect the photon assays will come in with higher gold values.

urango Resources was mentioned in my editorial column at 7 cents on August 8th, 2019. The company's stock has been a slow mover but when gold moved last summer, Durango took a run to .175. I thought I'd give an update. I still own it.

The Market

The stock traded back and forth between .12 and .155 for about 3 months and then took a dive to .06 in December. Unhappy shareholders? Previous private placements exiting? Slow results due to Covid-19?

DGO traded 10 Mil+ shares in January and hit .135 then back down to .085.

On Thursday DGO announced an update which included hiring a new IR group, Core Consultants (Pty) out of the UK at a cost of \$40,000USD per month for 3 months. The stock traded 1.2Mil shares on Friday hitting .12 closing at .11 on the TSX Venture. I would predict a financing is coming. Are new highs coming? The big \$\$ exposure could help. Time will tell.
