Gold is Bouncing Around

Since our last newsletter, gold has traded up to \$1834 and then started a slide. We are back under \$1800 (currently \$1797) and another set of fireworks is lined up for Wednesday!

On Wednesday we have the triple red event:

1) First the US interest rate decision at 12:00 EST which we all know will remain the same.

2) Then at the same time the Monetary Policy Statement is released. This is where the "language" in the statement is over analysed & the markets move.

3) Then at 12:30 EST comes the FOMC press conference where Jerome Powell, the Fed. Chair gives a prepared statement and then answers questions which adds to the market volatility.

It will be interesting to see if Gold can break through the resistance and make moves up to the \$1850 level or will Powell's speech strengthen the US\$ and push gold lower to retest \$1765 US/oz?

ur featured company is focused on the exploration and development of flake graphite in Quebec for the new green economy.

Lomiko is a Canadian-listed junior graphite exploration and development company. It's flagship asset is the La Loutre graphite deposit, located in Quebec, Canada about 120 km north-west of Montreal and 53 km southeast of the currently operating Imerys Graphite and Carbon Timcal Lac des Iles graphite mine.

The La Loutre deposit currently has an NI 43-101 compliant resource estimate completed in 2016, with 4.1 M tonnes of 6.5% flake graphite in the indicated category and 6.2 M tonnes of 6.1% flake graphite in the inferred category based on a cut-off grade of 3% in a open pit.

Lomiko plans on updating their resource estimate soon, integrating drilling data from 2019 in the property's Refractory Zone which features some notable, relatively long and high grade intercepts that would expected to add tonnes and potentially improve the grade of the overall deposit.

EXPLORATION



C olonial Coal (CAD TSX Venture) continues to rebound after hitting its 2021 low of .50 on June 22nd. Colonial closed at .84 up a dime since our last newsletter came out! It has been trading very strong lately and maybe we will see a new 2021 high soon.

The Tormont Group put out an update on Colonial Coal, click on the Tormont50 icon to read the report.

The stock price is reflecting the coal being valued at about .22CA/MT. I'm predicting if a deal gets done it will be in the \$2US/MT+ range, but what do I know? #DEEPVALUE

What I know is Coking Coal prices continues to rise, the world wide infrastructure programs will need steel, and Colonial Coal has 695MT sitting there for the right buyer.

I own it for the 10 bagger potential! Do your own research on this value stock.



G atling Resources (GTR TSX Venture) continues to linger at year lows. On July 12th they closed the first tranche of their financing, which was \$2.32 million.

On July 13th they acquired the remaining 25% interest in certain mining leases on the western portion of the Larder property, known as the Swansea zone. Upon closing they will own a 100 percent interest minus a maximum \$275,000 6.25% net smelter royalty on the property.

On July 20th Gatling signed an Exploration agreement with First Nations groups .

So things are progressing and I look forward to more drill results, and an updated resource estimate later this year.

D urango Resource (DGO TSX Venture) continues to trade lower. The stock closed at 6 cents on Monday. The impatient are taking their loss. TD remains a net buyer.

On July 14th Durango finally put out assay results from 3 drill holes they did on their East Barry property. One hole contained gold values, but they were anomalous values ranging from .132 to .629 g/t Au.

Durango is still waiting on assays from holes drilled this year at their Trove property.

Durango will have to raise more funds for further exploration. I would love to see them sell their Mayner's Fortune limestone property in BC to help reduce further dilution.

Maybe Bonterra (BTR TSX Venture) will take a swing at Durango for the land positions. I'm not sure how this will unfold but my patience is wearing thin.

These are levels in the chart where support and resistance are likely to occur. The levels are 23.6%, 38.2%, 61.8%, and 78.6%. 50% is often added but is not an official level. The levels are calculated from two points chosen by the user, usually an extreme low and an extreme high.
